A Package > Every business that is interested and that intends to establish or develop a business in Miskolc is entitled to make use of the "A" package of the basic services.

B Package > The basic services may be made use of by a business which undertakes that the number of those employed in the establishment affected by the development is increased by at least twenty-five individuals and an investment of at least 100 million Hungarian forints (HUF) is realized, or an increase in net returns of at least 100 million HUF is achieved.

Advanced services › The basic services and the advanced services may be made use of by a business which undertakes that the number of those employed in the establishment affected by the development is increased by at least 100 individuals and an investment of at least 500 million HUF is realized, or an increase in net returns of at least 500 million HUF is achieved.

4. **The assumption of the cost of establishing the company**
